I. Call to Order, Proof of Posting, Proof of Notification

Larry Hawthorne presented the monthly activity for the Wheatley Recreation Center. Tarrant County Food Give Away dates are scheduled for August 7th, 21st and 28th and volunteers are needed. Mr. Hawthorne requested when the city is searching for grants, please consider the Wheatley Recreation Center.
